Colossians 3:23 ~ "let all that you do be unto the Lord"




Let your heart's motivation be to serve others through your business or ministry

Cost Structures

Luke 14:28 ~ "For which of you, desiring to build a tower, does not FIRST sit down and count the costs?"

- Faith-based stewardship: knowing the Costs Behind Your Calling
- The left side of the BMGC = Where Costs Are Born (Key Resources + Key Activities + Key Partnerships)

Key



Identifying with God the resources that are needed to serve and deliver value to customers

Examples: buildings, equipment, workers, and etc.

Isaiah 41:13 "...Fear not, I am the One who helps you.

Kingdom – mindset shift from costs being a burden to costs being an Investment!

Costs -> Investments -> Assets -> Generate Income

What are your top 3 key resources needed right now?

Key Activities

Are the operations within the business or ministry and it directly drives costs.

Do not be fearful of costs or spending "God's" money

Examples: manufacturing, develop internal system processes, and etc.

Kingdom – mindset is: Key Resources + Key Activities = Assets → Revenue

Deuteronomy 30:9 "...the Lord will bless the work of your hands..."

Key Partnerships

Who does God want our business or ministry to partner or connect with and how can we bless each other?

Examples: supply vendors, landlord of your building, joint ventures

Create Economies of Scale



Key Resources + Key Activities + Key Partnerships = Assets → Revenue

Ecclesiastes 4:9-10 "Two are better than one...if either of them falls down, one can help the other up."



Vision + Faith = Budget

To create a Budget you need to know the Vision for your business or ministry

- Budgets are a roadmap from God's vision
- Use your Faith to see beyond current resources
- Let your Budget be a testimony of Faith IN Action!
- Be flexible! Budgets are under constant construction



Categorize Your Costs

- Fixed Costs remain the same (rent, salaries)
- Variable Costs Change with activities (shipping, materials)
- Mixed Costs blend of fixed & variable (utilities)
